



NIGHT HUNT RULES + WAIVER AGREEMENT

By paying for and/or participating in this hunt, I agree to the following:

1) Payment

- **No credit cards.**
- **Deposit may be paid by check (deposit only).**
- **Balance is due in PAPER CASH ONLY the night of the hunt.**

2) "Pay to Play" / No Guarantee

- This is a **pay-to-play hunt** for a **chance** at an animal. No harvest is guaranteed.

3) Night Hunt / Equipment

- This is a **NIGHT HUNT (dusk till dawn)**.
- Feeders run through the night. Feeders are maintained regularly, but **mechanical failures can occur**, and we are not responsible for feeder failure during your hunt.

4) No Responsibility for Conditions / Disturbances

- We are not responsible for disappointment caused by factors outside our control, including (but not limited to): **human actions or noises, weather, wildlife, livestock, lights, other area hunters, or other disturbances.**

5) Blind-Only Rules

- This is a **low-fence, free-range, blind hunt.**

- You **MUST stay in the blind. No stalking allowed.**
- You may **ONLY shoot from the blind porthole** at the feeder. Shooting from any other position is not allowed.

6) Items That Can Void Re-Hunt Eligibility

Use of the following can produce poor results and may scare animals. **Use of these (or similar items) VOIDS your re-hunt:**

- Scent sprays
- Buck calls
- Any lights **other than red**
- Grain or buck attractants
- Cigarette smoke / vape pens
- Heaters
- Dip
- Pop-up blinds

7) Actions That Void Re-Hunt Eligibility

The following actions **VOID your re-hunt** (including but not limited to):

- Shooting from anywhere other than the blind porthole (“the shooter’s window at the feeder”)
- Any consumption of alcohol
- Any littering
- Theft of any equipment (including SD cards, game cameras, red lights, etc.)
- Starting fires
- Camping
- No-notice cancellations
- Lying
- Bad attitude / hostility

- Passing shot opportunities
- Wasting game

8) Refunds / Re-Hunts

- **NO REFUNDS** of any money.
- **Re-hunts are at my discretion** and based on availability.
- **No prime-time / flashback re-hunts.**

9) Assumption of Risk / Responsibility

- Hunting is dangerous. We are not responsible for injury caused by you, nature, or our facility.
- You and your group accept **100% responsibility** for anything that causes injury, damage, financial loss, violation of law, success, failure, death, or disappointment while hunting here.

10) Release of Liability

- By signing below, you agree to these terms and **release/absolve the landowner, lease holder, and our agents** from any legal action by you or the group you represent.

- You acknowledge that **any questions or concerns you had have been addressed completely** to your satisfaction.
